PART II

NARRATIVE SUMMARY

During August, 4th Battalion, 12th Marines was assigned the primary mission of General Support of 3d Marine Division. However, during the month, the battalion provided a "quick fire channel" to four Direct Support Battalions (1/12, 2/12, 3/12, and 4/12) concurrently and separately. The increased number of observed missions, quicker response time, and increased amount of damage inflicted on the enemy, can be closely correlated to these unofficial reinforcing roles. Some priority problems were encountered when all four battalions were reinforced at one time, however, these were minimal.

The battalion also provided Direct Support for as many as ten Reconnaissance teams at one time and fired two close-defensive fire missions which prevented two teams from being overrun.

Two platoons of LIMA Battery were in Direct Support of ARVN forces before displacing from Die Marker site C-1.

The battalion continued to exercise control over four 155 howitzer batteries, however, on the 17th of August, K/4/13 was chopped to 1st Marine Division in exchange for the 1st Provisional 155 Towed Howitzer Battery. This exchange resulted in a net loss of three howitzers.

Continuing to adhere to the principle of maximum centralized fire direction, the battalion continued to also control the technical fire direction of three batteries even though the flank batteries were laterally displaced almost 12 miles. Because of this control, the fires of the battalion have been massed many times quickly and accurately.

The battalion continued to control the tactical fire direction of the second platoon, 1st 8" Howitzer Battery located at the ROCKPILE; the second platoon, 5th 155 Gun Battery, at CAMP CARROLL; and the 8" platoon of the 5th 155 Gun Battery, at CA LU. Having these three units reinforcing the fires of the battalion, accounted partially for the ability for 4/12 to reinforce the fires of four Direct Support Battalions. It also gave, in essence, the Direct Support Battalions the opportunity to utilize 8" fires on active missions with a minimum of delay.
